A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SHOREACRES, TEXAS, AUTHORIZING THE REAPPRAISAL OF PROPERTY DAMAGED BY FLOODING ASSOCIATED WITH HURRICANE HARVEY DURING THE END OF AUGUST 2017 BY THE HARRIS COUNTY APPRAISAL DISTRICT; MAKING VARIOUS FINDINGS AND PROVISIONS RELATING TO THE SUBJECT; FINDING COMPLIANCE WITH THE OPEN MEETINGS LAW; AND PROVIDING AN EFFECTIVE DATE HEREOF.

WHEREAS, the State of Texas in Section 23.02 of the Tax Code authorizes the reappraisal of property damaged in a disaster area; and,

WHEREAS, the Governor of the State of Texas has declared a State of Disaster for Harris County; and,

WHEREAS, the City of Shoreacres lies within the territorial boundaries of Harris County;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SHOREACRES, TEXAS:

THAT the City Council of the City of Shoreacres, hereby requests that the Harris County Appraisal District re-appraise approximately 70 properties within the boundaries of the City of Shoreacres, as listed by the City Manager of the City of Shoreacres.

This Resolution shall take effect upon its passage and approval.
