The meeting was called to order by Mayor Moses at 7:00 p.m.

David Jennings moved to approve the February 22, 2016, regular council meeting minutes; seconded by Nancy Schnell. Motion carried unanimously

  - 5.1.1 <u>Update on State Highway 146 sound wall progress</u>: TxDOT is wrapping up the sound wall construction project.

#### 6.0 PUBLIC HEARINGS & PUBLIC COMMENTS

6.1 Public Comments:

Neil Moyer – 1124 N. Country Club: Item 8.2; disappointed in the delay. Item 8.3; council needs to bite the bullet and move on to address future repair costs. Item 8.5; speed limits, the city has an ordinance about this and it should be left as is:

there is a big difference between 20 and 25 mph. Item 8.7; a bit premature at this time.

<u>Darlene Gamble Bays – 616 Baywood</u>: Item 8.7 should be deferred for the new council group to handle; there are too many issues in the proposal. Noticed that some residents continue to put out heavy trash. Need to utilize Blackboard Connect to let residents know that heavy pick-up is not available at this time. Suggested council approve the bid amount of \$250,000 for the sewer repairs and not the lump sum amount of \$350,000. Opposed to the 25 mph speed limit, it is too fast for our small city.

<u>Gerry Victor – 3346 Miramar</u>: Opposed to the ordinance that will raised the speed limit from 20 mph to 25 mph. Does not like the process. City Administrator is not a resident and isn't around on weekend to witness speeding violations. City of La Porte and Deer Park are lowering their speed limit throughout the city. Suggests council to seek legal advice before voting on this for the sake of our children and citizens.

<u>David Tidwell – 3308 Sunrise</u>: There are talks around the neighborhood about the city administrator contract. Questions missing funds for sewer line repair. Would like clarification from council about these two items.

<u>James Hester – 3523 Bayou Forest</u>: In agreement with all residents here tonight that the speed limit. 25 mph is too fast, there should be a way around state law.

<u>David Gerany – 3316 Miramar</u>: Questioned the proposal of Ordinance 2016-201. Asked if this was a directive from the State or is the city is going backwards. We have a large expense for sewer line repair. Should utilize our police force to generate revenues to cover for some of these expenses. Would like to see a speeding ticket revenue comparison of current to prior year. We are missing out on a revenue opportunity.

<u>Chuck Haist – 122 Meadowlawn</u>: Opposed to Ordinance 2016-201 increasing speed limit from 20 to 25 mph. It is too fast for our small town.

8.3 Consideration and action to approve of Ordinance No. 2016-199 adopting Budget Amendment I to the General Fund and Utility Fund Budget of the City for Fiscal Year 2015/2016 to provide supplemental appropriation and/or transfer of certain funds for emergency expenditure to repair the city's water and sewer system.

Mike Wheeler moved to adopt Ordinance No. 2016-199. Seconded by Richard Adams.

David Jennings moved to amend the Resolution to move \$15,000.00 from line item 6820-50 to line item 6820-50 and reduce the amount taken from unrestricted/unbudgeted reserves to \$275,750. Seconded by Nancy Schnell. Richard Adams, David Jennings, Jerome McKown and Nancy Schnell voted Aye; Mike Wheeler voted Nay. Motion passed.

A vote on the original motion was called. Motion carried unanimously.
